3.1.1 Pending = Direct distributions have been implemented –(50% of operating budget overage has been distributed to member schools = \$243,691.50 in 2011-12; \$250,000 in 2012-13; \$218,312 in 2013-14) Operating Budget has not exceeded two years operating Revenue.

- 3.1.2 Implemented direct fund distribution to member schools based on championship participation 50% of all Interest and Dividends earned (\$150,000 shared with schools in 2011-12; \$242,267.50 in 2012-13; \$258,350 in 2013-14).
