The schedule issues that I had last season were as follows:

Pine Lake Prep. They were late with their schedule because they were trying to locate a home venue and smaller schools to book in the area. The final schedule was set just before the season. I did have the conference schedule well in advance of the deadline. I didn't have any problem with this and cut him some slack since the program and AD were new. (So was I, so I was learning in "real time".

Community School of Davidson. Schedule issues as well because they were having to locate home venues within the Mecklenburg Co. school system. Again, I was aware of the dates, but not the locations. Not a real issue because it too was a first year program.

PROBLEM: I received my booking fee from Pine Lake Prep on November 14, after the regular season. I sent them three "past due" notices after the original invoice was sent to them on June 1. One issue that I believe caused this problem was that, if I remember correctly, I was paid by the Booster Club, not the school. The charter schools seem to have different funding structures than public school counterparts.

We discussed this briefly on Saturday, but I'm not in favor of either proposal.

When I get additional schedules from them, they send an entire schedule and then I have to go through them to determine which games I already had. I would much rather receive a complete, correct schedule by January 15. Just my .02 worth.

As far as schools not paying the Regional Supervisors, this has never been a big problem for me. I do have some that may be tardy, but I will then send the invoice in care of the bookkeeper and almost always a check appears shortly thereafter.



Mark,

Of the 11 High Schools I assign, only 2 (Murphy HS and Franklin HS) submit schedules prior to December 15th. This is typical every year, but mostly due to the fact that I have always given them until the first Monday in February (in my contract). I do this because schedules given to me prior to December 15th would be so inaccurate, that they would basically be useless.

The other issue I have is that half of my schools never know if they are having JV teams or not (baseball and/or softball). For that reason, I never invoice for booking fees until first or second week of March when that all becomes clearer. As example, <u>Cherokee HS added a JV baseball team just today!</u> I have already invoiced them so I sent an updated one today to include JV baseball (\$100), also charged them a re-booking fee for each game change to a Varsity/JV DH where umpires had already been assigned to work a single game.

I'm all for requiring an on-time schedule, but would that \$100 fine be paid to the NCHSAA or Regional Supervisor? Seems we would be the ones with the extra work if late. As for Booking Fees, if they have an on-time schedule, then I can invoice earlier so that would be great as well. No umps until fee is paid. I always tell them if they are unsure about JV teams, include them because its easier for me to delete them than to add in the arbiter.

I know I havent really given you what you are asking. I havent had any issues getting my booking fees. The schedules are the big thing. I would be more supportive of a \$75 re-booking fee. It seems I am doing those all of the time and it is a lot of work, not just a couple of clicks. Those JV games I had to add for cherokee, well one guy in one crew doesnt work the plate, so I had to take him off, find another ump on another game who can work the plate, take him off his original game, then assign them each to their respective new games. Its a LOT more than just a couple of clicks. If nothing else, take out the option for a school to pay a one-time \$100 to cover all changes. I'm losing money if anyone ever takes that option.

I think my schools could get schedules on time if they just got to work finding games earlier. I know the conference games can be done earlier, but they just need to find their non-con games earlier also. I support the late schedule fine as well as the no-fee paid, no-ump policy.

Hello Mark,

I have a school in Yancey county (Mnt. Heritage) that will not pay until the season is totally over. I have Cherokee High that is a whole other problem that seems to be connected with the Federal Government/Cherokee Council. It has been a battle to get them to pay, their schedule is usually totally screwed up and this year, they refused to pay the officials individually and I had to bill them for their entire season first and they paid me a lump sum. I then paid each official.

I do not see a "due date" in this year's handbook and I assume it would be in the statement where the booking fee is stipulated. I feel that this is a great idea as well as the idea that schools must pay the officials either by check or ref pay.

Generally, my schools in the West are the slowest to pay and also the ones with the most schedule problems. They have conflicting dates and what school is hosting the match. Robbinsville and Swain are generally on top of their game, but Andrews, Hiwassee Dam, Hayesville and a mess. I normally have to send more than one booking notice. If they are in the football playoffs, I have learned not to bug them as it will do me no good but waste my time. I feel that the AD's should be on top of all of this, but I get a sense that they are also the football coaches and do not have time. If I deal with the wrestling coach (and if he is on staff), I seem to get more done as he bugs the AD.

My pay late schools this year were-AC Reynolds, Hendersonville High, Madison HS, Pisgah HS, Mtn Heritage HS
On another note, many schools in our area want our officials to fill out a W-9 before each match, which is not a
problem for us, but they also want us to put our Social Security number on the paper. I told my guys not to do that as
the information is already on Arbiter and we are not giving a stranger (normally the gate keeper) our SS numbers. I went
round and round with several of them (AD's and bookkeepers) and had to give the SS over the phone after I got it off of
the Arbiter site myself. The problem here is that they are not using/do not know how to use the site. I am not sure how
they got to wrestling season without using Arbiter, but I can see when they log in (or do not log in). I am nice and help
them out, but it is very time consuming. Many of the AD's go on the site and then funnel the info to the bookkeeper so
that the bookkeeper never gets on the site.
