4. Gfeller-Waller Sanctions for Non-Compliance

- \$1000 fine for failure to have documentation of a signed Concussion Information Form for any person. If the person is a:
 - Student Athlete
 - He or she is removed from further participation until the education component is completed
 - o Parent
 - The student athlete is removed from further participation until the parent completes the education component
 - o Coach, or athletic staff member
 - He or she is suspended from coaching until the education component is completed
- \$1000 fine for returning a player to practice and/or play without a signed RTP Form
 - The program may also be suspended from further participation.
 - We need to develop a timeline, however it could be written "to be determined by the NCHSAA"
- \$1000 fine for failure to have a certified Emergency Action Plan for all athletic programs
 - o The entire athletic program may be suspended from further participation
 - We need to develop a timeline, however it could be written "to be determined by the NCHSAA"
- \$500 fine per venue for failure to post venue specific emergency action plan, with the amount not to exceed \$2,500

5. Education and Athletics Committee Recommendations- Sanctions for Failure to Field Requisite Sports for Conference Membership

- \$1000 fine upon first occurrence
- Multiple occurrences
 - No consensus with regard to if violation occurs more than once in a four-year alignment period, or within a four year period (from the occurrence)
