1. Transfer Waiver Policy Application

- 1A. <u>Recommendation:</u>. Review the NCHSAA's Transfer Waiver Policy as it applies to the North Carolina School of Science and Math (NCSSM).
- a. <u>Rationale:</u> The NCCSM receives a large influx of students each year and the volume of paperwork processed by NCCSM has prompted them to request a review of the rule's application to the institution, and whether additional concessions may be necessary.
- b. <u>Budget Impact:</u> NCCSM has noted the cost of printing the information for it's incoming class as well as mailing the information to the previous member school has been considerable in their opinion.
- c. Educational Impact: none
- d. Equity Impact: none
- e. Effective Date: 2015-2016 School Year
- 2A. <u>Recommendation:</u> Review the NCHSAA's Transfer Waiver Policy as it applies to student's admittance to Member Charter School's after being waitlisted on or before initial entry.
- a. Rationale: There have been some students who have appealed the NCHSAA's denial of their transfer waiver request and indicated that the Charter School was their school of choice for initial entry but were denied entry due to the lottery process/waitlist. There should be some discussion as to whether the policy unduly hinders opportunities for students under the aforementioned circumstances. There have been many appeals to the NCHSAA from denials of the transfer waiver policy from students who have indicated that they have been on a waitlist for their Charter School of choice for a number of years and transferred as soon as they were chosen through the lottery process. There must be sufficient and appropriate documentation provided to ensure that the spirit of the rule is not lost, if indeed a policy is

- adopted to address Charter Schools' position in the transfer waiver policy debate.

 - i. The 365 day limitation imposed by the transfer waiver rule abuts the two-semester rule for eligibility, and there may be some variance in the way eligibility is determined if examining the rules in conjunction with one another.
- 4A.<u>Recommendation:</u>. For Discussion Only. NO ACTION. Advise NCHSAA Staff on best practices for processing and receiving information for transfer waiver requests during the summer months.
- a. Points of Emphasis:
 - During the summer months, schools are not fully staffed and the ability to receive necessary information to process transfer waiver request is significantly diminished.

Proposed Provisions

2.3.17

Member schools retain the broadcast rights to their regular season contests, with the exception of the NCHSAA TWC Game of the Week, and are encouraged to make their own arrangements with media outlets. The NCHSAA retains all broadcast rights to the NCHSAA TWC Game of the Week. The NCHSAA also holds the broadcast rights to all postseason competition it conducts whether broadcast over the air, TV, cable TV or the internet.

Additional Provisions

NCHSAA TWC Game of the Week

- Time Slots: The NCHSAA Game of the Week will be conducted during the Fall and Winter sports seasons for the sports of football and basketball. During the Fall Sports Season the NCHSAA TWC Game of the Week will be held on Thursday, and on Monday or Thursday during the Winter sports season.
- If forces beyond the NCHSAA's and Member Schools' control make broadcast of the NCHSAA Game of the Week impracticable, the NCHSAA and TWC may select alternate sports to be broadcast during the aforementioned time slots, or an alternate date to broadcast the NCHSAA Game of the Week.
- The NCHSAA, in conjunction with Time Warner Cable, will consider equitable coverage of all member institutions when selecting participating member schools for the NCHSAA TWC Game of the Week.
- Live internet video streaming of the NCHSAA TWC Game of the Week is expressly prohibited absent prior written approval by the NCHSAA.
- 2.3.17.f Live regular season telecasts of football and basketball games by NCHSAA member schools are prohibited.
 - However, member-schools outside of the Time Warner Cable footprint, may upon prior written approval, make their own arrangements with media outlets for live telecasts during the aforementioned time slots. (This may be added after we "test" live coverage)
- 2.3.17 Live internet video streaming of regular season contests is permitted, with the exception of the NCHSAA TWC Game of the Week, which requires prior written NCHSAA approval.

I have read, understand and acknowledge receipt of the eligibility rules of the North Carolina High School Athletic Association. I understand that a copy of the *NCHSAA Handbook* is on file with the principal and athletic administrator and that I may review it, in its entirety, if I so choose. All NCHSAA bylaws and regulations from the *Handbook* are also posted on the NCHSAA web site at www.nchsaa.org

I understand that an NCHSAA member school must **adhere to all rules and regulations** that pertain to the interscholastic athletics programs that the school sponsors, but that local rules may be more stringent than NCHSAA rules. I understand that participation in interscholastic athletics is a **privilege not a right**.

Student Code of Responsibility

As a student athlete, I understand and accept the following responsibilities:

I will respect the rights and beliefs of others and will treat others with courtesy and consideration.

I will be **fully responsible** for my own actions and the consequences of my actions.

I will **respect the property** of others.

I will **respect and obey the rules** of my school and laws of my community, state and country.

I will **show respect to those who are responsible for enforcing the rules** of my school and the laws of my community, state and country.

I understand that a student whose character or conduct violates the school's Athletic Code or School Code of Responsibility could be deemed ineligible for a period of time as determined by the principal or school system Administration

I understand that if I drop a class, take course work through Post Secondary Enrollment Option, or other educational options, this action could affect compliance with NCHSAA academic standards and my eligibility.

Informed Consent – By its nature, participation in interscholastic athletics includes risk of injury and transmission of infectious disease such as HIV and Hepatitis B. Although serious injuries are not common and the risk of HIV transmission is almost nonexistent in supervised school athletic programs, it is impossible to eliminate all risk. Participants have a responsibility to help reduce that risk. Participants must obey all safety rules, report all physical and hygiene problems to their coaches, follow a proper conditioning program, and inspect their own equipment daily. PARENTS, LEGAL CUSTODIAN'S OR STUDENTS WHO MAY NOT WISH TO ACCEPT RISK DESCRIBED IN THIS WARNING SHOULD NOT SIGN THIS FORM. STUDENTS MAY NOT PARTICIPATE IN AN NCHSAA-SPONSORED SPORT WITHOUT THE STUDENT'S AND PARENT'S/GUARDIAN'S SIGNATURE.

I understand that in the case of **injury or illness requiring treatment by medical personnel and transportation to a health care facility**, that a reasonable attempt will be made to contact the parent/legal custodian in the case of the student-athlete being a minor, but that, if necessary, the student-athlete will be treated and transported via ambulance to the nearest hospital.

I consent to medical treatment for the student following an injury or illness suffered during practice and/or a contest.

I understand all concussions are potentially serious and may result in complications including prolonged brain damage and death if not recognized and managed properly. Further I understand that if my student is removed from a practice or competition due to a suspected concussion, he or she will be unable to return to participation that day. After that day, written authorization from a physician (M.D. or D.O.) or an athletic trainer working under the supervision of a physician will be required in order for the student to return to participation.
