#### **PRACTICE SCHEDULE**

Practice Schedule- The practice times for Land O Lakes Golf Course will be after 12:00 on Saturday and before 12:00 on Sunday, April 28<sup>th</sup> and 29<sup>th</sup>. It is free if you walk, otherwise, it will be\$15.00 per person to ride. There should be an adult in each group that rides. I would prefer teams and individuals that will be driving back and forth to practice on Saturday, and those who will be spending the night to set up their practice on Sunday. You will need to contact the golf course at (910)-642-5757 to set up a practice time. Also on Monday, a cart will be assigned to each head coach and those working the regional, but not assistant coaches. If a parent wants to ride a cart, it will cost them \$20.00 per cart not person. It will be first come first serve and you cannot reserve one prior to the day of the regional. Range balls for the day of the match will be \$2.50 per basket.

### **REGIONAL GAMEDAY SCHEDULE**

**7:30** Golf Course Opens

Coaches- as you start arriving at the golf course, you will need to walk into the clubhouse, and head straight back to the back room, where I will be with your packets. The golf course is charging for range balls. After you pick up your pack, you will be able to walk out the back door to your golf carts, which will have your names on them. Please let your parents know the golf course will be renting carts until they run out. It is first come, first serve.

**8:30** All players, coaches, and spectators are to gather in front of the clubhouse for us to meet and go over the guidelines and rules.

9:00 The first groups will tee off.

**11:00** Coaches meeting will be in room where you picked up your packets.

#### NCHSAA 2A MIDEAST REGIONAL LOCAL RULES SHEET

#### LAND O LAKES GOLF CLUB

All play is governed by the 2016 USGA Rules of golf and Decisions, with the following local rules in effect:

**THE ONE-BALL RULE IS NOT IN EFFECT:** Any ball found on the USGA's conforming list may be used in this competition.

**DOUBT AS TO PROCEDURE:** When a competitor is doubtful of his rights or procedure for play, he may, without penalty, complete play with two balls. Before playing, the player must: 1) Announce his intention to play two balls, and 2) Announce which ball he intends to score with, rules permitting. The player **MUST** report the facts to the rules committee before returning his card. Penalty for failure to do so is disqualification (Rule 6-3).

**EMBEDDED BALL:** "Through the green", a ball that is embedded in its own pitch mark may be lifted, cleaned, and dropped as near as possible to the spot without penalty. The ball must first strike a part of the course through the green. *Exceptions:* 1. A player may not take relief under Local Rule if the ball is embedded in a sand area that is not closely mown. 2. A player may not take relief under Local Rule if interference by anything other than the condition covered by Local Rule makes stroke clearly impractical.

**WATER HAZARDS:** Water hazards are identified by yellow lines. Lateral water hazards are identified by red lines. When a lateral water hazard is defined only on one side, it is deemed to extend infinitely. When hazards are bounded by out of bounds, the margin extends to and coincides with the out of bounds line.

Drop Areas: There are drop areas available for use on holes #9, #10, #14, and #18. The drop area on #9 is on the front of the closest tee box (red tee box). The drop area for #10 is on the next tee box forward of the blue tees. The drop area on #14 is on the tee box to the left and closet to the water. The drop area on #18 is on the tee box closest to the water (red tee box).

**GROUND UNDER REPAIR:** Defined by white lines. White-lined areas tying into cart paths and obstructions are part of those obstructions.

**OUT OF BOUNDS:** Defined by the inner edge of white stakes at ground level. Out of bounds can be found on the following holes: #1- The inside edge of the road on the golf course side is considered the boundary. #6- Right of cart path. #12- Right of cart path up to pond. Reappears after pond past green on right. #- Behind the green, #8-left of second fairway and green, #9- Right of fairway and bunkers, #13- Right of fairway and cart path past green. #18- Inside edge of the road on golf course side is boundary.

**OBSTRUCTIONS:** The clubhouse is deemed an obstruction and is in play. There are two drop areas for any balls ending up on/around the clubhouse and in bounds but not through the green. Players should proceed to the nearest drop area. The pump house on hole 9 is deemed an obstruction. Players will be granted line-of-sight relief for a ball behind the pump house. Players should proceed to the nearest of two drop areas for relief.

**DISTANCE MEASURING DEVICES:** A player may, in competition, use a device intended for measuring distance only.

**SPECTATORS/SPECTATOR CARTS:** Must remain on the cart path at all times.

**SUSPENSION OF PLAY:** For dangerous situations, on long blast of the horn will suspend play **IMMEDIATELY.** For non-threatening situations, three short blasts will suspend play, with the option being up to the competitors to finish play of the current hole.

CELL PHONES ARE NOT ALLOWED UNDER ANY CIRCUMSTANCES. USE OF A CELL PHONE IS AUTOMATIC DISQUALIFICATION.
