1. We have a 14-member team with one alternate. We have consistently traveled 12 different players so that we would not accumulate excess absences in their 7th period classes. So if 1 or 2 starters remained in class, I would simply move up players to higher flights.
2. Our number 5 player, senior Clay Alderman had a lingering case of mono and preformed poorly in the early season challenges and practices. By the week of April 2nd, he returned to full strength and he earned his spot in our starting line up in singles. His progression in health allowed him to also move from number 3 doubles to number 2. Consequently Rutledge Smith and Jack Phillips who played mostly 5 and 6 singles moved down to 6 and 7.
3. In all of our matches our 1, 2, 3, 4 (Zimmermann, McLean, DeSiva, and Singh) have never played lower than 4. For the most part they have played in that sequence for most of the year.
4. This season was unique for us as we had 44 players try out for our teams. We kept 14 plus one alternate on Varsity and 15 JV players. We try to create playing opportunities for our non-starters.
5. We move players up in the line-ups but never down to gain an advantage.

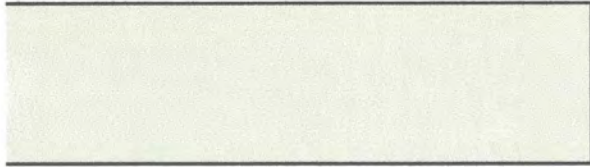




