- Coolers
- Drones/Unmanned aerial vehicles
- Fireworks
- Food or Drink of any kind*
- Food or Drink containers (bottles, cans, thermos, etc.)
- Ice Bags
- Illegal Substances
- Laser Pointers
- Poles/Sticks for Flags or Signs
- Selfie Sticks, Signs/Banners/Flags larger than 3' x 2'
- Sitting/Standing in the aisles
- Strollers (large, non-collapsible; collapsible strollers permitted)
- Throwing objects in stands or onto field
- Tobacco Products (Includes Vaping)
- Large Video Cameras and Go Pros (hand-held still cameras are permitted)

*Exceptions will be made for those with medical requirements or special needs; fans should carry necessary documentation, credentials or identification; diaper bags permitted only if accompanied by an infant.

For the safety of our patrons, all guests entering the stadium complex are subject to search as permissible by law. Refusal is grounds to prohibit admission.
