**Rationale:** Ensure that schools are following proper protocol when tracking yellow card accumulation and subsequent suspensions when limits have been reached. Coaches, athletic directors and regional supervisors currently have no mechanism for verifying the number of yellow/red cards an individual has accumulated. This uncertainty possibly leads to intentional or unintentional manipulation of NCHSAA Handbook policy.

6. Basketball

5-Quarter Rule (NCBCA)

**\*\*Attachment S4\*\***

To allow 9<sup>th</sup> and 10<sup>th</sup> grade players only to participate in five (5) quarters of basketball games on the same day.

Proposed Language:

“A student shall not participate in more than five quarters per day and in not more than 23 games per season (except if team plays an additional Endowment game), exclusive of Conference Tournaments and State Playoffs. Overtime periods shall be considered an extension of the previous quarter, and participation for any length of time in a quarter shall constitute a full quarter. For the purposes of this rule, participation during the same day in five quarters shall be considered participation in one game.”

**Rationale:** Schools are struggling to field both varsity and JV programs. This would allow schools to place players on each team commensurate with their playing level and ability, while allowing for the flexibility of adding depth for the varsity contest.

## 2020 Football Contact Limitation BOD Proposal

***Joint Recommendation from a sub-committee comprised of the NC Football Coaches Association Board and members of the NCHSAA Sports Medicine Advisory Committee***

1. During the spring skill development period for football, between April 15<sup>th</sup> and the last ten (10) student days of second semester, Level 3 (Bump) may be used for a maximum of 60 minutes total (Limitation of up to 15 minutes per day).
2. After the conditioning requirements are met for pre-season practice (August), teams are limited to a maximum of 15 minutes of Live Action Contact (Level 4) per group, per day.
3. Pre-season scrimmage time allowance will be reduced from seven (7) hours, to five (5) hours with a required minimum of 48 hours (recommended 72 hours) in between any scrimmages. This competition can be between two (2) schools or with multiple schools.
4. Once the regular season begins (Monday of Play Week #1), teams are limited to a maximum of 15 minutes of Live Action Contact (Level 4) per group, per week.

## Football Drill Categories

- a. Non-Live Action (Allowed at any time outside of established dead periods and Sundays)
  - i. Level 0 (Air)
    1. Players run a drill unopposed without contact
  - ii. Level 1 (Bags)
    1. Players run a drill against a hand-held bag or another soft-contact surface.
  - iii. Level 2 (Control)
    1. Players run a drill at coach-assigned speed
    2. One player is predetermined the “winner” by the coach
    3. Contact remains above the waist and players stay on their feet.
- b. Restricted Non-Live Action (Limitations in place for off-season skill development)
  - i. Level 3 (Bump)
    1. Players run a drill at competitive speed with no wrapping up of a ball-carrier
    2. No predetermined “winner”
    3. Contact remains above the waist, players stay on their feet, and a quick whistle ends the drill
    4. Allowed during the spring skill development period for football
      - a. Between April 15<sup>th</sup> and the last ten (10) student days of 2<sup>nd</sup> semester
      - b. May be used for a maximum of 60 minutes total
        - i. Limitation of up to 15 minutes per day
    5. Allowed during in-season practices once acclimatization mandates are met
      - a. No daily/weekly time limitations

- c. Live Action (Allowed during in-season practices once acclimatization mandates are met)
  - i. Level 4 (Full Live Action Contact)
    - 1. Drill is run in game-like conditions and is the only time that players are allowed to be taken to the ground.

## Meeting of the Board of Directors – Agenda Item Submission

**Name(s):** Greg Grantham (Ex. Director), Henry Drake (President), Scott Harrill (Vice President)

**LEA/Conference/Group:** NC Basketball Coaches Association

We/I request that the following item be placed on the agenda for the next meeting of the NCHSAA Board of Directors:

**Recommendation/Proposal:** (State in detail the recommendation/proposal): Basketball (both boys & girls) should have a rule that allows players (9<sup>th</sup> & 10<sup>th</sup> graders only) to be allowed to participate in 5 quarters of basketball games on the same day.

Sample wording: A student shall not participate in more than five quarters per day and in not more than 23 games per season (except if team plays an additional Endowment game), exclusive of Conference Tournaments and State Playoffs. Overtime periods shall be considered an extension of the previous quarter, and participation for any length of time in a quarter shall constitute a full quarter. For the purposes of this rule, participation during the same day in five quarters shall be considered participation in one game.

This rule could even be expanded to include that a team can only use a player in 5 quarters in a situation where there are fewer than 11 players listed in the scorebook for that contest. It would/should truly be for situations that would avoid having to end a season because of lack of numbers or potentially end a game with only 4 players on the court for one team.

- **Rationale:** (Why should the board consider and possibly pass this recommendation?)  
As a result of the increase in sport specialization, there are a number of schools across the state that are finding it difficult to field both JV and Varsity basketball teams (particularly on the girls side). Schools are starting the season with only 8 or 9 players on the team (either JV or Varsity) and often lose 1 or 2 during the season, leaving them with the unenviable options of either cancelling the season or starting games with only 7 or 8 players dressed for games. In some cases it forces schools to either not field a JV team altogether, or cancel the remainder of the JV season and merge 2 teams into one, thus forcing the younger players to lose valuable playing experience.  
  
There are over 30 other states that allow basketball players to either A) play 5 or 6 quarters on the same day at different levels (JV & Var), or B) allow players to play 2 different basketball games on the same day. In North Carolina, the NCHSAA rules already allow Baseball, Softball and Volleyball players to participate in 2 full contests at different levels on the same day.
- **Budget Impact:** (What does this mean to a school's/athletic department's finances?)  
This rule change would have minimal if any budgetary impact on school's athletic department finances.

## Attachment S4

- **Educational Impact:** (Does this mean loss of school time? Does it interfere with study time?) There would be no educational impact nor additional loss of school time.
- **Gender Impact:** (Is this proposal fair to males and females?) The rule would be the same for both Boys and Girls Basketball. However, in most cases it would be of greater benefit to Girls Basketball programs as they are seeing a steady decline in JV participation numbers across the state.
- **Effective Date:** (When would this go into effect?) We recommend that this rule go into effect for the 2020-21 School year.

## PARTICIPATION GUIDELINES

Overscheduling of competitive events, overuse injuries and burnout have become too common in youth basketball. The tables below outline **recommended** and **maximum** amounts of youth basketball participation, as well as **rest** guidelines for young athletes, designed to promote a fun and healthy playing experience.

### RECOMMENDED PARTICIPATION GUIDELINES

Age	Game Length	# of Games Per Week	Practice Length	# of Practices Per Week
Ages 7-8	20-28 min	1	30-60 min	1
Ages 9-11	24-32 min	1 to 2	45-75 min	2
Ages 12-14	28-32 min	2	60-90 min	2 to 4
Grades 9-12	32-40 min	2 to 3	90-120 min	3 to 4



## MAXIMUM PARTICIPATION GUIDELINES

*The maximum participation guidelines outlined above and guidance on camps and academies below are intended to serve as limits on a young athlete's participation in organized basketball. It is possible that participation in organized basketball within the maximum limits but in excess of the recommendations is also not advisable from a health and wellness standpoint; however, this issue requires further study.*

*\*Youth basketball players, parents, and coaches should demonstrate caution in scheduling or participating in more than one game per day, especially on consecutive days. If young athletes participate in an event or tournament in which more than one game is played per day on consecutive days, players should have additional time off from sports activities following the event to allow for recovery.*

*\*\*It is recommended that young athletes in these age ranges who are approaching the maximum hour limits not participate in another organized sport concurrently.*

**Recommendation/Proposal: (State in detail the recommendation/proposal)**

**Allow Indoor Track teams the right to participate in three contests per week.**

**Rationale: (Why should the board consider and possibly pass this recommendation?)** Indoor track is the only winter sport that is often contested outside, and frequently events are postponed or cancelled due to weather. When meets are rescheduled, conflicts are created, especially if the school already has two (2) meets scheduled. The schools are often placed in the situation of having to either back out of local competitions, or cancel what might be their only opportunity to compete on a true indoor track (JDL Fast Track). Qualifying for the Indoor State Championship meet is based entirely on best marks recorded anywhere during the season. One of the goals is to get your best athletes to big meets to find better competition. Competition makes one better! By entering a single athlete into an invitational, this counts as one of the teams two meets for that week. Also, outdoor track and other sports (basketball, soccer, lacrosse, golf) are allowed three contests per weeks. Tennis, Baseball and softball are allowed to compete in four contests per week.

**Budget Impact: (What does this mean to a school's/athletic department's finances?)** It will not affect the individual school's finances.

**Educational Impact: (Does this mean loss of school time? Does it interfere with study time?)** It will not affect the school day or loss of time.

**Gender Impact: (Is this proposal fair to males and females?)** Yes.
