The purpose of this communication is to communicate a few key issues that I would like to convey to all Athletic Directors within the Mountain Conference.

First, I always get excited this time of year knowing that Basketball is around the corner. This being said, Covid has and is still presenting challenges that none of us could ever have imagined. Prior to Covid, WNC was blessed to have a full staff of officials desiring to officiate High School Basketball. At that time, we were fortunate to avoid the steady decline of officials in all sports. Last season, however was completely abnormal and we all worked together to create as normal as possible scenarios on all fronts.

As we approach this season, I was hoping and expecting a return to normalcy with our HS referees. Unfortunately, this has not occurred, and as a result, we are again falling far short in our numbers as a result of the following:

1. Some who sat out last season due to Covid have chosen not to return
2. Some of our officials are just too busy to officiate due to work and family commitments
3. Many of our Officials have received expanded college opportunities and can no longer dedicate the time to also officiate HS games.

Apart from the experienced referee drop offs from our roster, we have the largest incoming class in my 9 years of new referees. Though this is exciting news for WNC Basketball, we still will not have the necessary numbers to fulfill the normal schedules as we know prior to Covid.

Therefore, I am asking all Athletic Directors to return to last year's format for games on all nights and Saturdays to ensure that we can fulfill these games with officials.

Secondly, I am asking all schools to provide marked parking spaces as close to the gymnasium as possible for the upcoming season. This alone will benefit our officials with their overall experience in game assignments. I understand as well that all of our schools are struggling with personnel as well, however this adjustment, if not already provided would be a wonderful touch.

Thank you for your continued support, and as always, I will do whatever necessary to exceed the needs of our Student Athletes, Fans, and School Administrators.

Coach Carver,

As per our conversation this am, I completely understand the dilemma this puts on all of our athletic departments as you are dealing with other winter sports as well.

Therefore, let me try to examine this closer and put into perspective.

Fact: we do not have the numbers to accommodate all Tuesday and Friday assignments as they are today. The bulk of these weekly game numbers are played on

Tuesdays and Fridays.

Note: an average of 77% of the games for the week are now scheduled for Tuesday and Friday

It is possible that we have 13 Home dates on any given Tuesday and Friday

Possible assigning- 13 games x 3 officials per game= 39 Varsity Officials

13 games x 2 Officials per game,(JV)= 26 Officials

65 Total Officials Needed

Fact: I am short of Officials, and this includes 100% of the staff officiating these games

On any given Tuesday/Friday, I can normally count on 70-80% of the staff to work based on college games, and all other parameters causing

officials to close these dates. Injuries throughout the season also account in these numbers

WNC Basketball Staff Numbers today: 55 Referees, (that is if I can get them all eligible)

Available Officials on a given Tuesday/Friday- $(55 \times .75) = 41$ Officials

2018-19 season- 103 Officials

2019-20 season- 90 Officials

2020-21 season- 49 Officials

2021-22 season- 55 Officials, includes 12 Officials who have resigned due to

1. College assignment schedules
2. Covid concerns, have just decided to not return
3. Job Responsibilities
4. Retirement due to age

Based on these Numbers, the maximum No. of Home Dates that can be scheduled is 9 games:

9 Varsity games x 3 Officials per game= 27 Officials

9 JV games x 2 officials per game= 18 Officials

45 Total Officials Needed

Solution Options:

1. Utilize The Recommendation as presented exactly

2. Utilize the recommendation in some facsimile thereof to include each conference move games as assigned on No. 1 to another day during that week, (their choice)
3. Review of each Tuesday and Friday schedule of games and depending on No. of games that exceed 9, notify each conference assigned to move in that respective week

Example: Tuesday, December 14

13 Home Games are now scheduled, 54 Officials needed

4 Home Games need to be moved to a Mon, Wed, Thurs or Sat-

- Mountain Athletic and Mountain 7 are assigned to move games that week based on Recommendation presented

Mtn Athletic: Asheville, Erwin & N Buncombe have Home games- 1 game rescheduled

Mtn 7 Conf: Pisgah & Tuscola have Home games 1 game rescheduled

Mtn Foothills- Hendersonville & Brevard- none have Home games

Private Schools- 4 Home games- 2 games rescheduled

Notes: 1. if this option is selected, it is up to the discretion of the Supervisor of Officials to require which conferences are to reschedule their games for all

weeks during the season; No. 1 format to be utilized

2. Each Conference Chairman will be notified by Nov 15 as to the request for changes for Nov & Dec

3. Supervisor of Officials will be notified by Nov 21 as to all game changes within that specific conference for Nov & Dec

4. Each Conference Chairman will be notified by Dec 1 as to the request for changes for Jan & Feb

5. Supervisor of Officials will be notified by Dec 8 as to all game changes within that specific conference for Jan-Feb

Final thought: Option No. 3 appears to potentially be the most accommodating for all schools, however this also places much additional work on the Supervisor of

Officials to make these changes. I am willing to invest the time to do this, however ALL SCHOOLS must respond when requested for their changes.

- Teams compete against each other in a larger structure
- Season-long schedule of matches or tournament
- All participants adhere to a set of singular rules
- Competition in games rated either “E” for everyone or “E10” for everyone 10 and up

WHY ESPORTS?

- Inclusion – Estimated 2.5 billion gamers worldwide
- 45% of all PlayVS players – First time participating in afterschool activity
