Overtime periods shall be considered an extension of the previous quarter, and participation for any length of time in a quarter shall constitute a full quarter.”</p> <p><i>The Coaches Association would also be amenable to a change that would allow for student-athletes to dress for two (2) basketball contests per day.</i></p>	<p>Rationale: Schools are struggling to field both varsity and JV programs. PARTICIPATION GUIDELINES

Overscheduling of competitive events, overuse injuries and burnout have become too common in youth basketball. The tables below outline **recommended** and **maximum** amounts of youth basketball participation, as well as **rest** guidelines for young athletes, designed to promote a fun and healthy playing experience.

RECOMMENDED PARTICIPATION GUIDELINES

Age	Game Length	# of Games Per Week	Practice Length	# of Practices Per Week
Ages 7-8	20-28 min	1	30-60 min	1
Ages 9-11	24-32 min	1 to 2	45-75 min	2
Ages 12-14	28-32 min	2	60-90 min	2 to 4
Grades 9-12	32-40 min	2 to 3	90-120 min	3 to 4

MAXIMUM PARTICIPATION GUIDELINES

Age	# of Games Per Day	# of Hrs. Per Week in Organized Basketball
Ages 7-8	1	3 hours
Ages 9-11	2*	5 hours
Ages 12-14	2*	10 hours**
Grades 9-12	2*	14 hours

The maximum participation guidelines outlined above and guidance on camps and academies below are intended to serve as limits on a young athlete's participation in organized basketball. It is possible that participation in organized basketball within the maximum limits but in excess of the recommendations is also not advisable from a health and wellness standpoint; however, this issue requires further study.

**Youth basketball players, parents, and coaches should demonstrate caution in scheduling or participating in more than one game per day, especially on consecutive days. If young athletes participate in an event or tournament in which more than one game is played per day on consecutive days, players should have additional time off from sports activities following the event to allow for recovery.*

***It is recommended that young athletes in these age ranges who are approaching the maximum hour limits not participate in another organized sport concurrently.*

PURPOSE

The purpose of this proposal, presented to the North Carolina High School Athletic Association, is to formally request that women's wrestling be sanctioned as a high school sport in North Carolina, and be provided a women's NCHSAA championship event.



SANCTIONING WOMEN'S WRESTLING

1. Implementation of Girls Wrestling: The proposed plan is to have a transition period that would permit women the option of participating in both their school's men's lineup and women's lineup during regular season contests only. If a tournament only hosts a men's division, then women will have the option of competing in the men's division. If a tournament offers both a men's and women's division, then women would be required to wrestle in the women's division. After the sanctioning of women's wrestling, women would only participate against women at women-only competition and must participate in the women's postseason only.

2. Weight Classes: The NCHSAA will utilize the NFHS weights for women's wrestling. The women's weight classes will be released to all member schools, by the NCHSAA before the first competition date each season.

3. Contest Limits: Women and men will both follow the same contest limitations as listed in the NCHSAA Board Handbook Rule 44, Article 6.



SANCTIONING WOMEN'S WRESTLING

4. Coaching and Practices: A NCHSAA member school who offers both men's wrestling and women's wrestling are permitted to use the same coaching staff to oversee both teams. Furthermore, both the men's and women's wrestling teams that consist of enrolled students from the same school or an approved cooperative may practice at the same time in the same practice facility under the guidance and leadership of the same coaching staff.

5. Postseason and Qualifying Events:

There will be one classification for the NCHSAA Women's Wrestling Championships. Seeding will be determined by several criteria, including overall record, returning placers from the year before's championship, and placement at selected events throughout the regular season.

Future consideration may be given to the addition of regional qualifying events once merited by increased participation numbers.



SANCTIONING WOMEN'S WRESTLING

NCHSAA Women's State Tournament:

1. The State tournament will be established in an 16-person bracket format
2. The State tournament will be held initially in conjunction with the men's dual team state finals. Preliminary rounds would be conducted on Friday, with championship matches contested on Saturday.
3. The top 4 place finishers at the state tournament will be recognized as state medalists.
4. The top 2 team finishers at the state tournament will be recognized as team trophy winners

Recommendation/Proposal: (State in detail the recommendation/proposal):

Proposal: Modify NCHSAA Sports Season Dead Period Rule 2.2.14(d) (1) (vi) by allowing Cross country Skill Development Sessions during the NCCA Clinic Week.

Rationale: (Why should the board consider and possibly pass this recommendation?)

Rationale: There is unmeasurable value in knowing the rules and the latest training and coaching techniques that a coach receives from attending any workshop, especially the annual North Carolina Coaches Association Annual Clinic. Skill Development Sessions, commonly known as “workouts” are valuable to the development of the athlete. The week of the NCCA Coaches Clinic is a “Dead Period” in which Sports Development Sessions are prohibited. The week of July 4 is also a “Dead Period.” During the week of the NCCA clinic, a “Dead Period” day of workouts should occur only on the day(s) of an individual sport’s clinic and rules session. For example, cross country sessions are held on Wednesday. Cross country teams should have the right to hold workouts on Monday, Tuesday, Thursday and Friday. The same principle could apply to the other sports. This proposal is geared toward cross country.

Cross country athletes create their “base” during the summer months in order to complete the 3.1-mile race course. The 2021 season’s first day of practice was August 2 with the first meet being held on August 16. For the 2022 season, July 4-July 17 will be “Dead Periods”. Two weeks of the athletes not being able to work-out with their coach is not in the best interest of the athlete. Two weeks of no training for a sprinter, football or volleyball player just prior to the start of the season is not the same as that of a distant runner. They’re not running 3.1 miles non-stop. This also lends itself to the athletes training by themselves unsupervised or with an unqualified individual.

The additional supervised workout days in the July would help the cross country athletes become acclimated to the heat as they prepare for mandatory practices beginning August 1. This is keeping in line with the NCHSAA Fundamentals of Heat Prevention and Management for all Sports. (2.3.2)
