NIL Checklist - For School Use Only

Pursuant to a court order, the State Board of Education's proposed Rule 16 NCAC 06E .0211 applies to name, image, and likeness ("NIL") agreements during the current school year. The NCHSAA applies the same rule to all membership entities. This checklist is intended to assist in compliance with the rule.

**Please confirm that all of the following are true.** If any of these criteria are not met, the NIL agreement does not comply with the NIL rule.

\_\_\_\_\_ The NIL agreement does not condition the receipt, type, or extent of any compensation to the student on the extent or quality of the student's athletic performance.

\_\_\_\_\_ If the student is under age 18, the student's parent or legal guardian is a party to the NIL agreement.

\_\_\_\_\_ The NIL agreement includes language stating that the following parties shall be held harmless from any liability related to or arising from the NIL agreement: (1) the governing body of the PSU or membership entity in which the student is enrolled, as well as the officers and employees of that governing body; (2) the NCHSAA, as well as its officers and employees; and (3) the State Board of Education and the Department of Public Instruction, as well as their officers and employees.

\_\_\_\_\_ The NIL agreement complies with state and federal law.

\_\_\_\_\_ The student provided a copy of the NIL agreement to the principal and athletic director of the student's school, the local superintendent, the chairperson of the PSU governing body, and the head coach of any sport in which the student will participate during the term of the agreement (except that students at non-boarding parochial schools need not provide the agreement to a local superintendent, and shall provide the agreement to the chairperson of the membership entity's governing body).

\_\_\_\_\_ The student completed the NFHS NIL education course.

\_\_\_\_\_ If the student is under age 18, the student's parent or legal guardian also completed the NFHS NIL education course.

\_\_\_\_\_ The NIL agreement does not require reference to/use of/display of the intellectual property (i.e., name, uniform, mascot, mark, logo) of a school, membership entity, conference, the NCHSAA, or the NFHS.

\_\_\_\_\_ The NIL agreement does not require promotion/endorsement of goods and services during interscholastic athletic competition or school events.

\_\_\_\_\_ The NIL agreement does not require promotion/endorsement of (1) an adult establishment/adult entertainment services, (2) alcohol/alcoholic products, (3) tobacco, vaping, or nicotine products, (4) cannabis/related products, (5) controlled substances, (6) opioids or prescription drugs, (7) weapons, firearms, or ammunition, (8) casinos or gambling, including sports betting; or (9) activities that would disrupt the operations of a school or membership entity.
